WHAT TO KNOW

Automotive Technology (AU) The Automotive Technology program is accredited by the Automotive Service Excellence Education Foundation in Maintenance and Light Repair (MLR). Successful students will be able to gain ASE student level certification in MLR, and CCAR safety. They will also have an opportunity to receive certification in preventative maintenance, brakes, suspension and steering, engine repair, engine performance, automatic transmission, manual transmission, electrical and HVAC. The course is taught by ASE Master certified technicians. Approximately 315 technician jobs are projected to be needed in our region in the next year.

CLASSROOM AND PROGRAM HIGHLIGHTS

The Automotive program offers articulated credit with post-secondary institutions and may meet Michigan Merit Curriculum final-year math experience graduation requirements. The program features ASE certified equipment, every day hands on practical lab application, and an accredited learning program that provides self-paced instruction. The program is ASE Education Foundation accredited with an ASE Master certified instructor. Students will learn about the entire vehicle in the Maintenance and Light Repair area and a sharper focus on Engine Repair, Electronics, Engine Performance, Brakes, and Steering and Suspension.
