WHAT TO KNOW

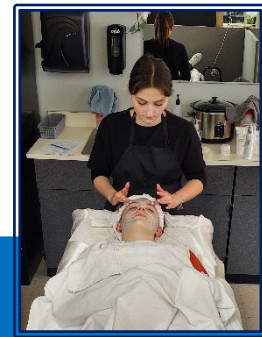
The Cosmetology course is a two-year commitment for those students pursuing the required 1,500 hours of instruction for their State of Michigan Cosmetology license. Students enroll as a senior in high school and must return after high school graduation to complete the 1,500-hour requirement. High school students concentrate on theory and practice hands-on skills utilizing mannequins and each other. Students returning may be required to fill out an application to continue their studies in theory and practical work, as well as, operate the Touch of Class Salon where students experience real-life salon situations. Students completing the program may apply to take the Michigan Cosmetology Exam and upon passing the test, they will be licensed as a cosmetologist.

CLASSROOM AND PROGRAM HIGHLIGHTS

Student performance expectations include completion of unit assessments at 75% and above, meet 1500 hour requirement, completion of all minimum practical applications and participate in practical experience requirements. Program will prepare you to successfully pass the Michigan State Board of Cosmetology exam, equip students with career-ready practices, salon experience and technical skills. Classroom activities can include artificial nail application and design, anatomy and physiology, facials, hair cutting as well as performing manicures and pedicures.

YOUR FUTURE

Become a licensed cosmetologist by passing the Michigan State Board of Cosmetology Exam. Other careers include Color or Nail Technician, Esthetician, Make-Up Artist, Platform Artist, Product Educator or Salon Trainer and a Salon Owner.



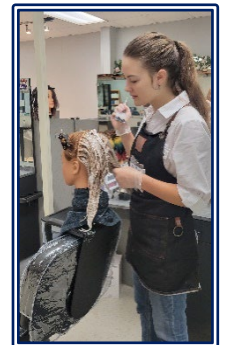
