ACADEMY DESCRIPTION

These courses are designed for students interested in one of the following areas :

- Emergency Medical Service

This academy will explore and learn what is required to perform as a certified EMT.

Students will achieve this by being presented with the academic knowledge, and the hands-on skills needed to pursue a future in these career path.

PHYSICAL FITNESS DESCRIPTION

THE NATURE OF EMS INDUSTRY IS VERY PHYSICALLY DEMANDING. AS A RESULT THESE ACADEMIES WILL HAVE SOME SORT OF PHYSICAL TRAINING EVERYDAY IN CLASS, THIS MAY BE A FORMAL ACADEMY SESSION IN THE CLASS, A LARGE GROUP WORKOUT WEDNESDAY, OR VERY INTENSE JOB RELATED FUNCTIONAL WORKOUTS. PROPER REST, NUTRITION, SLEEP AND HYDRATION ARE KEY FOR THE STUDENT, ANY ILLNESSES OR INJURIES SUSTAINED IN CLASS OR OUTSIDE OF CLASS SHALL BE REPORTED TO THE INSTRUCTIONAL STAFF PRIOR TO THE START OF CLASS.

ACADEMY SPONSORS

Mecosta County EMS, in cooperation with the Mecosta-Osceola Intermediate School District Career Center (as approved by the State of Michigan), is the course sponsor for the EMT advanced learning. **A copy of the approved application for class and schedule is available in the classroom.**

INCLEMENT WEATHER

The MOCC Public Safety class uses the same Closure/Cancellation policy as the MOISD.

MATERIALS

TEXT: Provided to students as a classroom resource. Books are available to sign-out & take home if needed.

EMT: Emergency Care and Transportation of the Sick and Injured 12th Edition

SUPPLIES: Paper, pen or pencil – all provided by the student.

UNIFORM: ONCE PROVIDED BY MOCC, **UNIFORMS SHALL BE REQUIRED TO BE WORN AND INSPECTED EACH DAY PRIOR TO THE START OF CLASS.**

BLUE PANTS(PROVIDED BY STUDENT)
BLUE POLO FOR EMT(PROVIDED BY SCHOOL)
BLACK BOOTS OR SHOES(PROVIDED BY STUDENT)

HEALTH AND SAFETY

Students work in squads and must understand they will be in close contact with others, so **cleanliness** and **good personal hygiene** is expected on a daily basis. Due to the nature of the program there will be absolutely **NO HORSEPLAY**. Any horseplay can, and will, result in discipline up to and including dismissal from the program.

Any violations of policy or, the student handbook, or any violations of “Conduct unbecoming” shall result in a required “**Memo**” to be typed and signed by the student and a parent prior to be turned in for review by MOCC staff. The Memo Template will be provided to the students, required documentation will include, the policy violated, the violation committed with an explanation, corrective action the student is going to take.

CELL PHONE POLICY

Unless authorized prior by the instructor Cell phones are NOT allowed to be used in class unless used during designated break time (break is based on student passing inspection). Any student using a cell phone in class will be subject to discipline. Phones will be able to be secured in the instructor's office during school hours, and field trips (per their request), or may be kept in student backpacks. The phones are not to be kept on their person unless prior approval by the instructor.

* Any phone brought into the classroom is the responsibility of the student

LEAVING THE ACADEMY CLASSROOM -

If a student needs to use the restroom they may do so after telling their squad leader they are leaving. During our break (typically half way through class) students can leave the room if they are granted permission, they may not just roam the school. Break is **only** for students who passed inspection at the beginning of class.

SMOKING/FOOD & BEVERAGE/STUDENT BEHAVIOR POLICY

Students are expected to comply with Career Center policy.

ATTENDANCE -In accordance with Career Center Attendance Policy. Absences may affect a student's certification, grade, and returning for a Segment Q program. Some assignments may not be made up if not in attendance due to field trips, presenters, and classroom assignments. **BOTH CLASSES HAVE ATTENDANCE REQUIREMENTS DICTATED BY MICHIGAN LAW, AND MUST BE ADHERED TO ON TOP OF SCHOOL POLICY.**

SUCCESSFUL ACADEMY COMPLETION

In order to be a COMPLETER in the EMT or Fire Academy a grade of C- or better is required. This grade will be the result of all career readiness, homework, quizzes, tests, Midterms, Finals and, an end of class self reflection paper(APA formatting will be used and 6 total pages are required including the title page and reference page). The State of Michigan Firefighter 1&2 written and Practical testing for certification will have no weight on the students final grade should they qualify to test. The National Registry of EMT's written boards results will have no weight on the students final grade **should they qualify to attempt certification. Students will be authorized to take the certification tests on an individual basis, completion of the class does not guarantee being allowed to certify.** Being allowed to certify is based on Academic performance, Career Readiness grades, adherence to the guidelines from the Bureau of Fire Service and State of MI EMS Objectives and minimum points(both will be provided in class), if the student wants to attempt certification.

- All students are able to download the "Speak it" extension for reading tests individually
- Administering of assessment by a qualified person who is familiar to the student
- Tests may be taken in an alternative setting when requested
- Provides auditory, visual, or physical cues to students to begin, maintain, or finish tasks
- Verbal Praise
- Directions are clarified, repeated, or reworded when necessary
- Preferential seating when able (student is responsible to advise instructor)
- Teacher-directed instruction
- Multiple modes of learning – computer, verbal, visual, written
- Extended time for work completion as determined by the teacher(s).
- Concepts and skills are related to meaningful examples
- Large assignments broken into small tasks.
- Visual schedules and learning targets/success criteria are posted.

GOOGLE CLASSROOM and SKYWARD

Students will be responsible for checking Google Classroom from home if they are absent. GC and Skyward will be checked in class every Wednesday. This will allow the students to gain access to classroom assignments, content missed while absent, & their grades. It is the responsibility of the student to complete work and make sure the information is accurate every week.

ADDITIONAL INFORMATION

Within the field of Public Safety there are things viewed for learning purposes that the typical High School student may not be used to seeing. Some examples of this would be the Mecosta County Morgue tour, hospital tour, severe burn victim photos, work based learning calls, disturbing dispatch content, medical procedures and, some nudity(EMT only child birth and textbook content)etc. I always give students the option to step out of the room during difficult content.
